MINUTES

1. Opening procedures – The Rev. Paul Schumacher

This Annual General Meeting (AGM) of the Vestry was held in person in the sanctuary of All Saints by-the-Sea.

Quorum – as per Canon Regulation 6.7.01(f):

- f. In parishes with 200 or fewer electors, the quorum for transacting any business at an annual or special meeting of parishioners shall be:
 - i. the incumbent, or, if the incumbency is vacant or the incumbent is absent for any cause, the priest or deacon in charge, if any,
 - ii. at least one churchwarden or deputy warden, and
 - iii. not fewer than ten of the electors of the parish, present in person or by proxy.

And a "parishioner" is defined in the Canons as follows:

"Parishioner" is any baptized person who shall have been in regular attendance at a church of the Diocese for a period of not less than three months.

Attendance was recorded by a sign-in sheet: **45 people** were in attendance including the Interim Priest and 2 churchwardens (+ 1 Deputy Warden), and thus a quorum was achieved.

2. Notice of Chair - Rev Paul

As per Canon Regulation 6.7 (c)

c. The incumbent or nominee shall be the chair of the meeting. If the incumbency is vacant, or if the incumbent is absent for any cause, the meeting shall elect one of the churchwardens as chair.

The Interim Priest In Charge, The Rev Paul Schumacher, as chair, opened the meeting with prayer at 11:56am, notice of the meeting having been duly given over the past 2 weeks, according to Regulation 6.7.01(d).

a.	Notice of every such meeting must be given in writing or printing, signed by the convener, and posted up conspicuously at or near the church door, at least ten days before the day on which the meeting is to be held. The notice must state the time and place at which, and the purpose for which, the meeting is to be held; and shall be in the following form:

Nigel Desbottes expressed concern about the presentation of our Budget – Warden Ruth address his concerns by noting that our Budget was reviewed by the Diocese who have confirmed we are in compliance with all accounting regulations

- 11. Presentation of 2024 budget: Bishop's Warden Ruth Seltner on behalf of our Treasurer
 - Andrew has been optimistic on Givings, but regardless we are proposing a Deficit Budget, offset by a generous In-Kind endowment we were blessed to receive in 2023.
 - Additionally, A Family Place has been renting our Rectory for the past 15+ years at a substantially below market rate of \$775 but we can no longer afford this subsidy.
 - o New terms (for one year) are to increase the rental rate to \$1500

- Colin Lawler has asked for clarity re. the 50% increase in annual Assessment to the Diocese Rev Paul noted that the diocese is due a portion of all bequests made to our Parish—regardless of the fact that we've yet to leverage these funds ourselves (earmarked for Renovations)
